**MAJOR ISSUES OF

Wal-Mart Stores East, LP, ("Wal-Mart") and Sam's East, Inc., ("Sam's") hereby submits their list of major issues pursuant to Order No. 567320. As customers of Oklahoma Gas and Electric Company ("OG&E"), Wal-Mart and Sam's are concerned with any issues in this proceeding that may adversely impact the amounts or the rates they must pay for electric service.

Wal-Mart and Sam's are still in the process of analyzing the testimony and other evidence submitted by OG&E, and have not yet finalized their position. Thus far, however, the primary focus of Wal-Mart and Sam's is: 1) the inter-class allocations of OG&E's cost of service and of the requested revenue requirement, and 2) the design of rates.

This is not an exhaustive or exclusive list, but is an overview of Wal-Mart's major concerns. Wal-Mart and Sam's reserve the right to address other issues that may arise, and to participate in this proceeding to the extent, and by the means necessary, to protect their interests.
